

Bylaw n° 2015-027 of 15 June on the computer processing of data collected for educational administration and the provision of student services at Institut Polytechnique de Grenoble,

Having regard to Loi nº 78-17 du 6 Janvier 1978 Modifiée Relative à l'Informatique, aux Fichiers et aux Libertés (Data Protection Act),

Having regard to Décret n° 2005-1309 du 20 Octobre 2005 Modifié, concerning the application of the above mentioned Act,

Having regard to Arrêté Ministériel du 26 Janvier 1995 Portant Création d'une Application Informatique Nationale de Gestion des Enseignements et des Etudiants - APOGEE (National Software Application for educational administration and the provision of student services),

Having regard to the decision adopted by Amue on 27 mars 2013 on the alteration of the National Software Application for educational administration and the provision of student services,

Having regard to Arrêté du 16 Février 2012 Portant Création d'un Traitement Dénommé "Répertoire National des Identifiants Elèves, Etudiants et Apprentis" (creation of the National Directory of Pupils, Students and Apprentices Personal Data),

RULES AS FOLLOWS

- Article 1: Institut Polytechnique de Grenoble has obtained an APOGEE automated personal data processing system for the purpose of educational administration and the provision of services to Institut Polytechnique de Grenoble students.
- Article 2: Personal data can be transferred to third parties, namely the partner institutions listed in Annex 1.
- Article 3: Requests to exercise the rights to object to, to access and to have personal data rectified granted in articles 38, 29 and 40 of the law (loi no 78-17 du 6 Janvier 1978 Modifiée) is handled by Service Scolarité (Department of Admissions and Academic Affairs) of Institut Polytechnique de Grenoble.
- Article 4: Bylaw n° 2014-24 issued by the Chancellor of Institut Polytechnique de Grenoble on 27 june 2014 concerning the computerisation of educational administrative procedures and the procedures related to the provision of student services at Grenoble INP is abrogated as of the day the present bylaw is issued.
- Article 5: The Head of the Institut Polytechnique de Grenoble Support Service Units, and the Heads of the different member organisations are in charge of implementing the present bylaw in accordance with their own remit. The bylaw will be posted in the premises of the Support Service Units (Building B – Ground Floor) and of the member organisations. The bylaw comes into effect upon posting.
