### **◆ COMPULSORY FEES**

- Registration fees according to the ministerial order in force AND the institution's decisions regarding exemptions
- Not affected by the payment of these tuition fees:
  - students registered as part of an international exchange or to get a double-degree in association with a foreign higher education institute
  - students with apprenticeship status

- <sup>2</sup> This lowered rate is related to the students:

  - who are registered at the same time to get a double degree at Grenoble INP UGA
    - In the case of a double-course Engineering course / Master course, the registration in the Engineering course is considered as the main registration whose fees are to be payed at the full rate; the lowered rate of the tuition fees applies as for it to the Master course whose registration is then taken into account as a second registration.
